Safety Message to Installers of Warning Light Equipment

- When drilling into a vehicle structure, be sure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions packed with related products for additional precautions and information.
- Do not stare directly into the lights at a close range or permanent damage to your eyesight may occur.
- All effective sirens and horns produce loud sounds (120 dB) that may cause permanent hearing loss. Always minimize your exposure to siren sound and wear hearing protection. Do not sound the siren indoors or in enclosed areas where you and others will be exposed to the sound.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

Introduction

This publication has instructions for using the Bracket Kit to mount the ES100C and/or IMPAXX IPX600B, IPX300 or MicroPulse MPS600, MPS600U, MPS1200, MPS1200U, and MPSW9 lights in the upper grille of the 2015 Dodge Charger.

Unpacking the Kit

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts in the KIT CONTENTS LIST are included in the package. Disposal of all shipping materials must be carried out in accordance with national and local codes and standards. If you are missing any parts, contact Customer Support at 1-800-264-3578, 7 a.m. to 5 p.m., Monday through Friday (CT).

Installing the Brackets

A WARNING

AIRBAG DEPLOYMENT: Do not install equipment or route wiring in the deployment path of an airbag. Failure to observe this warning will reduce the effectiveness of the airbag or potentially dislodge the equipment, causing serious injury or death.

NOTICE

DRILLING PRECAUTION: When drilling holes, check the area you are drilling into to be sure you do not damage vehicle components. All drilled holes should be deburred and all sharp edges should be smoothed. All wire routings going through drilled holes should be protected by a grommet or convolute/split loom tubing.

IMPORTANT: Plan all cable routing before the installation.

- 1. To access the area behind the grille, remove the fascia per the manufacturer's service manual.




Figure 1 Exploded view of bracket secured to front bumper

- 2. See Figure 1. Using the bracket as a template, position the center of the bracket in the center of the bumper. Mark the mounting holes.
- 3. Drill the marked holes with a 13/64" drill.
- **4.** Install the bracket with three #14 screws and lockwashers. Do not over tighten.
- 5. Mount the speaker to the bracket with the 5/16" bolts and lock washers.
- **6.** Mount the lights to the bracket:

IPX600B uses hardware supplied with the lighthead;

IPX300 and MicroPulse use the 6-32 screws and KEPS nuts in this kit.

7. Complete the installation according to the instructions provided with the speaker and/or light heads.

▲ WARNING

- **8.** Test the lights and siren for proper operation.
- **9.** Reassemble the vehicle.
