Safety Message to Installers and Service Personnel of Emergency Vehicle Safety Equipment

- You should inspect the light system frequently to ensure that it is operating properly and that it is securely attached to the vehicle.
- When drilling into a vehicle structure, be sure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions packed with related products for additional precautions and information.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Failure to follow all precautions and instructions may result in property damage, serious injury, or death.

Introduction

This publication covers the installation of a Federal Signal ILS warning light system in the front headliner of a full size 2019 Ford Transit Low Roof. The part numbers in these instructions are for vehicle-specific mounting options that are ordered with the product. All mounting systems consist of aluminum shrouds and steel mounting brackets, all of which are powder coated. Mounting hardware is included with each kit.

Unpacking the Product

After unpacking the product, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of damage. Failure to identify damage before installation could lead to rejection of any claim. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts listed in Table 1 are included in the package. If you are missing any parts, contact Federal Signal Customer Support at 1-800-264-3578, 7 a.m. to 5 p.m., Monday through Friday (CT). Disposal of all shipping materials must be carried out in accordance with national and local codes and standards.

NOTICE

THREAD DAMAGE AND GALLING: To prevent thread damage and galling, anti-seize lubricant must be used on all stainless steel fasteners.

Mounting the Front ILS

A WARNING

AIRBAG DEPLOYMENT: Do not install equipment or route wiring in the deployment of an airbag. Failure to observe this warning will reduce the effectiveness of the airbag or potentially dislodge the equipment, causing serious injury or death.

NOTICE

DRILLING PRECAUTIONS: Before drilling holes, check the area into which you plan to drill to ensure you do not damage vehicle components while drilling. All drilled holes should be de-burred and all sharp edges should be smoothed. All wires going through drilled holes should be protected by a grommet or convolute/split-loom tubing.

IMPORTANT: Plan all cable routing before completing the installation. For wiring instructions, refer to instruction sheet 25500021.

- 1. Install the trim seal on the edges of the shroud that contact the windshield. Cut the strip to fit. See Figure 1.
- 2. Loosely attach the brackets to the shroud with the 1/4"-20 screws and external-tooth lockwashers.
- 3. Loosen or remove the visor mounts as necessary and slide the brackets between the mounts and headliner.
- 4. Ensure that the shroud is tight against the windshield. The trim seals may require trimming. In some cases the bulb is removed entirely, leaving just the edge trim. Tighten the hardware.
- 5. Repeat Steps 1 through 4 for the other side.

Outer Bracket

Trim the seal to fit the edges of the shroud that contact the window.
