## Safety Message to Installers of Warning Light Equipment

### **A** WARNING

- Do not install equipment or route wiring in the deployment path of an airbag.
- If a vehicle seat is temporarily removed, verify with the vehicle manufacturer if the seat needs to be recalibrated for proper airbag deployment.
- You should frequently inspect the light system to ensure that it is operating properly and that it is securely attached to the vehicle.
- When drilling into a vehicle structure, be sure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions packed with related products for additional precautions and information.
- Do not stare directly into the lights at a close range or permanent damage to your eyesight may occur.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

#### Introduction

This publication has instructions for using the Z861302757A Mounting Kit to mount a pair of MicroPulse® MPS650 lightheads to the B-pillars of the Dodge® Charger.

**NOTE:** For electrical installation instructions, refer to the installation and maintenance instructions packed with the lighthead.

# Unpacking the Kit

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts in the Kit Contents List are included in the package. Disposal of all shipping materials must be carried out in accordance with national and local codes and standards. ### **Installing the Brackets**

#### **A** WARNING

AIRBAG DEPLOYMENT: Do not install equipment or route wiring in the deployment path of an airbag. Failure to observe this warning will reduce the effectiveness of the airbag or potentially dislodge the equipment, causing serious injury or death.

#### **NOTICE**

DRILLING PRECAUTION: When drilling holes, check the area you are drilling into to be sure you do not damage vehicle components. All drilled holes should be deburred and all sharp edges should be smoothed. All wire routings going through drilled holes should be protected by a grommet or convolute/split loom tubing.

**IMPORTANT:** Plan all cable routing before the installation.

To mount a MicroPulse MPS650 bracket:






Figure 1 Bracket on the B-pillar

1. Position the bracket on the B-pillar as shown in Figure 1 and mark a wire access hole.

2. Drill a hole for wire routing.

- 3. Install the light head to the bracket using the supplied #10 screws and lock nuts. **Do not over tighten.**
- **4.** Install the light head/bracket assembly using the screws supplied with the light head. See Figure 2 for final assembly exploded view.

- **5.** Repeat steps 1-4 for opposite side.
- **6.** Complete the wiring according to the instructions supplied with the light heads.
- 7. Test the lights for proper operation.
