- Frequently inspect the light to ensure that it is operating properly and that it is securely attached to the vehicle.
- This product contains high-intensity LEDs. Do not stare directly into the lights at a close range, or permanent damage to your eyesight may occur.
- Refer to the instructions packed with related products for additional precautions and information.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Installing the MPS6U-SIL19RS6 Mounting Bracket Kit



To install the mounting bracket kit:

- 1. Following the vehicle manufacturer's instructions, remove the rear spoiler assembly.
- 2. Position the brackets as shown, and mark the six mounting holes. See Figure 1.




NOTICE

DRILLING PRECAUTIONS: When drilling holes, check the area you are drilling into to ensure that you do not damage vehicle components. All drilled holes should be deburred, and all sharp edges should be smoothed. All wire routings going through drilled holes should be protected by a grommet or convolute/split loom tubing.

3. With a 3/16-inch drill, drill the mounting holes through the spoiler.

- 4. Plan the wire routing. Drill through the vehicle structure if necessary.
- 5. Mount the brackets with 1/4-inch hex head screws and 1/4-inch lockwashers.
- 6. Install the light heads (not included) to both brackets with the supplied 6-32 screws and Keps® nuts.
- **7.** Reinstall the spoiler.
- **8.** Complete the wiring per the instructions supplied with the light heads.
- **9.** Install the cover plates with the black 8-32 thread-forming screws. See Figure 2.

10. Test the lights for proper operation.
