Safety Messages to Installers and Operators of Warning Light Equipment

A WARNING

People's lives depend on your proper installation and operation of Federal Signal products. It is important to read, understand, and follow all instructions shipped with the products and the original product. In addition, listed below are some other important safety instructions and precautions you should follow:

- To properly install this light, you must have a good understanding of automotive electrical procedures and systems, along with proficiency in the installation and use of safety warning equipment. Always refer to the vehicle's service manuals when installing equipment on a vehicle.
- DO NOT install equipment or route wiring in the deployment path of an airbag.
- When drilling into a vehicle structure, ensure that both sides of the surface are clear of anything that could be damaged.
- For the light to function properly, a separate ground connection must be made. If practical, it should be connected to the negative battery terminal. At minimum, it may be attached to a solid metal body or chassis part that provides an effective ground path.
- Locate the light control so the VEHICLE and CONTROL can be operated safely under all driving conditions.
- The effectiveness of an interior mounted warning light depends on the clarity, the tinting, and the angle of the glass it is being placed behind. Tinting, dirt defects, and steeply angled glass reduce the light output of the warning light. This may reduce the effectiveness of the light as a warning signal. If your vehicle has dirty, tinted, or steeply angled glass, use extra caution when driving your vehicle or blocking the right of way with your vehicle.

Installing SpectraLux ILS Lights in a 2020 Ford Police Interceptor Utility

- Do not attempt to activate or deactivate the light control while driving in a hazardous situation.
- Frequently inspect the light to ensure that it is operating properly and that it is securely attached to the vehicle.
- This product contains high intensity LED devices. To prevent eye damage, DO NOT stare into the light beam at close range.
- After installation, test the stick light to ensure that it is operating properly.
- If a vehicle seat is temporarily removed, verify with the vehicle manufacturer if the seat needs to be recalibrated for proper airbag deployment.
- After testing is complete, provide a copy of these instructions to the instructional staff and all operating personnel.
- File these instructions in a safe place and refer to them when maintaining and/or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

Product Overview

This publication contains instructions for installing a SpectraLux® ILS system into the rear hatch of a 2020 Ford® Police Interceptor Utility.

NOTE: For electrical installation instructions, refer to the Installation and Maintenance Instructions packed with the lights.

Unpacking the Kit

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, file a claim immediately with the carrier, stating the extent of damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. If you are missing any parts, contact Customer Support at 1-800-264-3578, 7 a.m. to 5 p.m., Monday through Friday (CST).

Installing the Warning Lights

A WARNING

AIRBAG DEPLOYMENT: Do not install equipment or route wiring in the deployment path of an airbag. Failure to observe this warning will reduce the effectiveness of the airbag or potentially dislodge the equipment, causing serious injury or death.

NOTICE


DRILLING PRECAUTIONS: Before drilling holes, check the area you are drilling into to be sure you do not damage vehicle components while drilling. All drilled holes should be de-burred and all sharp edges should be smoothed. All wire routings going through drilled holes should be protected by a grommet or convolute/split loom tubing.

IMPORTANT: Plan all cable routing before the installation.

To install the warning lights:


- 1. Install the extruded-rubber sealing strip on the edges of the shroud and cover that contact the rear window.
- 2. Remove trim panel from vehicle.
- **3.** Install bracket over the six factory-drilled holes in the vehicle and secure with pop rivets. See Figure 1.

4. Cut 1/4-inch clearance slots in the trim panel for the bracket (15.2 inches from center to center). See Figure 2.

5. Loosely install ILS unit to lower bracket using the supplied Keps nuts and flat washers. Slide housing forward until the edge of the housing contacts the glass. Tighten the Keps nuts. Do not overtighten keps nuts. Install the (4) nylon plugs. See Figure 3.

Testing the Warning System

▲ WARNING

SOUND HAZARD: All effective sirens and horns produce loud sounds (120 dB) that may cause permanent hearing loss. Always minimize you exposure to siren sound and wear hearing protection. Do not sound siren indoors or in enclosed areas where you and others will be exposed to the sound.

A WARNING

LIGHT HAZARD: To be an effective warning device, an emergency warning system produces bright light that can be hazardous to your eyesight when viewed at a close range. Do not stare directly into this lighting product at a close range, or permanent damage to your eyesight may occur.

After testing the flasher, test the emergency warning system to ensure that it is operating properly. Also test all vehicle functions, including horn operation, vehicle safety functions, and vehicle lighting systems to ensure proper operation. Ensure that the installation has not affected the vehicle operation or changed any vehicle safety functions or circuits. After testing is complete, provide a copy of these instructions to the instructional staff and all operating personnel.

Do not test the sound and light system of the vehicle while driving. Operating the vehicle warning systems may pose a hazard to the operator and other drivers if the systems do not function as expected. Test the vehicle only in a controlled environment.
