Safety Message to Installers and Service Personnel of Warning Lights

AWARNING

People's lives depend on your proper installation and servicing of Federal Signal products. It is important to read and follow all instructions shipped with this product. Listed below are some other important safety instructions and precautions you should follow.

- To properly install the lighting system, you must have a good understanding of automotive systems, along with proficiency in the installation and use of safety warning equipment.
- If a vehicle seat is temporarily removed, verify with the vehicle manufacturer if the seat needs to be recalibrated for proper airbag deployment.
- When drilling into a vehicle structure, ensure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions included with the light system for the proper electrical connections.
- To be an effective warning device, this product produces bright light that can be hazardous to your eyesight when viewed at close range. Do not stare directly into this lighting product at close range, or permanent damage to your eyesight may occur.
- Frequently inspect the light system to ensure that it is operating properly and that it is securely attached to the vehicle.
- Refer to the instructions packed with related products for additional precautions and information.
- File these instructions in a safe place and refer to them when maintaining or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

Overview

This publication provides instructions for installing AirTabs on the Valor light bar. Due to the combined aerodynamics, some vehicles with a Valor light bar exhibit unwanted noise. When installed on the bottom of the Valor, the AirTabs alleviate the noise.

Unpacking the Product

After unpacking the product, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of the damage. **Failure to identify damage before installation could lead to the rejection of any claim.** Carefully check all envelopes, shipping labels, and tags before removing or destroying them. Ensure that the parts listed in Table 1 are included in the package. If you are missing any parts, contact Federal Signal Customer Support at 1-800-264-3578, 7 a.m. to 5 p.m., Monday through Friday (CT).tighten the nuts.


Installing the AirTabs

AWARNING

ADHESION WARNING: The surfaces to which the AirTabs are applied must be clean and dry for proper adhesion. Use isopropyl alcohol (rubbing alcohol) to clean the mounting surfaces.

The four AirTabs are installed on the bottom of the Valor_® with the wide end facing front. See Figure 1.

The AirTabs are mounted left to right on 4-inch centers.

From the back of the light bar, the leading edge of the center pair is 13.4 inches or 12.6 inches with HotFoot nosemounted takedowns that are Opticom compatible. The outer pair sit 1-1/16 inches back from that.

To adhere the AirTabs to the bottom of the light bar, remove the backing paper and press each AirTab firmly in place.
