

Safety Message to Installers of Warning Light Equipment**⚠ WARNING**

People's lives depend on your proper installation and servicing of Federal Signal products. It is important to read and follow all instructions shipped with this product and the original product. Listed below are some other important safety instructions and precautions you should follow:

- To properly install the lighting system, you must have a good understanding of automotive systems, along with proficiency in the installation and use of safety warning equipment.
- If a vehicle seat is temporarily removed, verify with the vehicle manufacturer if the seat needs to be recalibrated for proper airbag deployment.
- When drilling into a vehicle structure, ensure that both sides of the surface are clear of anything that could be damaged.
- Refer to the instructions included with the light system for the proper electrical connections.
- To be an effective warning device, this product produces bright light that can be hazardous to your eyesight when viewed at close range. Do not stare directly into this lighting product at close range, or permanent damage to your eyesight may occur.
- Frequently inspect the light system to ensure that it is operating properly and that it is securely attached to the vehicle.
- Refer to the instructions packed with related products for additional precautions and information.
- File these instructions in a safe place and refer to them when maintaining or reinstalling the product.

Failure to follow all safety precautions and instructions may result in property damage, serious injury, or death.

Unpacking the Kit

After unpacking the kit, inspect it for damage that may have occurred in transit. If it has been damaged, do not attempt to install or operate it. File a claim immediately with the carrier, stating the extent of the damage. Carefully check all envelopes, shipping labels, and tags before removing or destroying them. 

Installing the SM CONTROL Control Head

To install the control head:


Assemble the included panel stand and select a location where the control head is easily accessible by the driver. Place the mount on the surface and screw on both screws, as shown in Figure 1, to secure the mount.

Once the mounting stand is fitted, fasten the control panel tightly onto the stand. Figure 2 shows the full exploded assembly including the control head and the permanent mount.
